REMARKS

Ventura County Operational Area in a Plan 2 Brush due to Santa Ana wind event.

Units dispatched to brush fire. Smoke showing while en route to fire. Supt. 11 established Staging at Balcolm Cyn Rd. x Highway 118. Staging then relocated to Balcolm Cyn x Stockton Rd. Supt. 11 on scene of a well established brush fire moving southwest at a rapid rate of spread due to east wind. Upgraded to 2nd alarm assignment. Branch management protocol initiated.

Battalion 11 IC initially then transitioned to DIV 11.

Fire burning at a rapid rate impacting structures and infrastructure. Companies performed immediate rescue and structure protection operations. Rotor-wing aircraft immediately put to work and reported 250 acres upon initial recon. Initial assessment of fire and conditions by ATGS allowed for no fixed-wing operations. Heavy equipment and crews engaged in perimeter control of the fire upon arrival. Evacuation orders and warning coordinated with VCSO and VC OES. Road

closures initiated throughout fire area.

Fire continued to impact landscape towards the southwest. Assessment made that potential existed for fire to move south of Highway 118. Branch 2 established with B11 for Camarillo Heights area. Branch 3 responsible for Camarillo Estates area. Direction given for life safety and property conservation as priorities for the incident. Fire spotted into foothills north of Camarillo. Companies shifted throughout all Branches to meet incident needs. Hundreds of calls received for immediate evacuation of civilians and fire impacts to residences. FMAG initiated. Decision made by Fire Chief and Deputy 11 to order Cal Fire IMT when fire moved south of Highway 118.

Branch 10 established with Supt. 12 for Highway 126 corridor north of South Mountain. Branch 7 established with B26 for west side of fire between Highway 118 and Santa Clara Rd. Branch 1 transitioned to B27. Branch 5 dissolved and combined into Branch 1. Branch 9 established with B14 for NW side of the fire from Wells Rd. to 12th street in Santa Paula. Branch 8 established with DIV 12 for Wells Rd from Santa Clara Rd to Highway 126. Evacuation orders and warnings updated and validated throughout initial attack.

Throughout the night, helicopters utilized for life safety and property conservation.

Operational briefing @ 0700 on 11/7/24 at VC Fairgrounds. 3 Branches and 8 Division organization built. Refer to IAP.

Cal Fire IMT 5 in-briefed at 0800 on 11/7/24.

VCSO and CHP addressed traffic control, assisted with evacuations and provided for scene security.
